The Edmunds County Board of Commissioners met at 9:00 A.M. on December 4, 2018 at the county courthouse. **EXECUTIVE SESSION:** Motioned by Hoyle, seconded by Thomas to enter into executive session at 9:20 A.M., according to SDCL 1-25-2(1). Motion carried. Executive session declared over at 9:35 A.M.

**LOCAL INFRASTRUCTURE IMPROVEMENT PROGRAM:** Motioned by Thomas, seconded by Davis to approve the South Dakota Local Infrastructure Improvement Program Grant Agreement, LIIP-18-04, between Edmunds County and the South Dakota Board of Economic Development, in an amount not to exceed \$375,000 or 45% of the total project cost. The grant is for township road improvements leading to Hybrid Turkeys facilities in Edmunds County. Motion carried.

**RESOLUTION – LIIP:** The following resolution was introduced by Commissioner Grosz, who moved its adoption: Resolution #2018-12-2, Local Infrastructure Improvement Program Certifying Officer. The motion to adopt the resolution was seconded by Thomas. Roll call vote: Olson - yes, Grosz - yes, Davis - yes, Hoyle - yes, Thomas - yes. Resolution adopted.

WHEREAS, the County of Edmunds has received a Local Infrastructure Improvement Grant, through the South Dakota Board of Economic Development; and

WHEREAS, Edmunds County is required to designate a certifying officer to sign the grant agreement, award policy, and all grant documents going forward.

NOW THEREFORE BE IT RESOLVED by the Edmunds County Commission that the Chairman of the Board of Edmunds County Commissioners be hereby designated as the County's official for the purpose of signing grant agreements and other required documents. This resolution is effective upon passage.

**NECOG AGREEMENT:** Motioned by Hoyle, seconded by Thomas, to approve and allow the Chairman to sign the Joint Cooperative Agreement with the Northeast Council of Governments for the year of 2019, in the amount of \$7,977.49, for the purpose of providing planning, technical aid, and assistance capabilities to its membership and other units of local governments. Motion carried.

**OMITTED ASSESSMENT:** Motioned by Grosz, seconded by Hoyle to add to the pay 2019 assessment roll a non-owner occupied improvement, in the amount of \$91,350.00, lot 1 of block 1 of Sunrise Addition to the City of Ipswich, owned by Allan Ochsner. Motion carried.

**SUPPLEMENT BUDGET:** Motioned by Thomas, seconded by Hoyle to supplement the Emergency Management Budget, in the amount of \$1,855.32, with American Society for the Prevention of Cruelty to Animals grant money received, per SDCL 7-21-32.1. Motion carried.
