The Edmunds County Board of Commissioners met at 9:00 A.M. on October 6, 2020 at the county courthouse. Motion carried.

RIGHT OF WAY OCCUPANCY: Motioned by Thomas, seconded by Hoyle to approve and authorize the chairman to sign the applications for Right of Way Occupancy with Northern Valley Communications to install fiber data cable under Edmunds County Highways in Cortlandt and Pembroke Townships. Motion carried.

SURPLUS PROPERTY: Motioned by Thomas, seconded by Grosz to declare one 1997 Le-10 finger print system, county tag #01957, as surplus county property and recycle. Motion carried.

WEED & PEST BOARD MEETING: Motioned by Grosz, seconded by Thomas to open the weed meeting at 9:25 A.M. Motion carried.

MINUTES APPROVED: Motioned by Thomas, seconded by Hoyle to approve the minutes of the May 5, 2020 Weed & Pest Board Meeting. Motion carried.

TRAVEL AUTHORIZATION: Motioned by Thomas, seconded by Grosz to allow Mike Jager and Ryan Schlechter to attend the SD Weed & Pest District Meeting in Redfield on November 4th. Motion carried.

WEED CONTROL: Michael Jager, Edmunds County Weed Supervisor, discussed a weed infested property that may need weed control enforcement.

Motioned by Grosz, seconded by Schaffner to adjourn the weed meeting at 9:35 A.M. Motion carried.
