- **JOINT POWERS AGREEMENT:** Motioned by Grosz, seconded by Davis to approve and allow the chairman to sign the joint powers agreement, between Edmunds County and SD Department of Transportation for Roadway Safety Improvement Sign and Delineation Project #PH0010(147) PCN 05HC. Motion carried.
- **COMMISSIONER DISTRICT 5:** Motioned by Davis, seconded by Grosz to accept the resignation of Wade Eisenbeisz and declare Edmunds County Commissioner District #5 seat vacant. Motion carried.
- **EMERGENCY MANAGEMENT:** Motioned by Grosz, seconded by Hoyle to approve and allow the chairman to sign the 2017 Emergency Management Performance Grant Subaward Agreement which allocates up to \$12,886.07 to be used for essential county emergency management expenses. Motion carried.
- **TRAVEL AUTHORIZATIONS:** Motioned by Davis, seconded by Hoyle to allow; Gwen Geditz, Patricia Nigg, Keith Schurr, and Lenny Uhrich to attend the SD County Convention in Rapid City on September 17-19, 2017. Motion carried.

PROVISIONAL BUDGET: Motioned by Grosz to increase the salaries of most county employees by 4% for 2018. Motion died due to lack of a second.

- Motioned by Davis, seconded by Hoyle to increase the salaries of most county employees by $3\frac{1}{2}\%$ for 2018. Motion carried.
- Motioned by Grosz, seconded by Hoyle to adopt the 2018 Provisional Budget in the following amounts: General Fund - \$2,165,197.00, County Road & Bridge Fund - \$3,470,231.00, Civil Defense Fund - \$61,230.00, RCW Fund - \$1,400.00, 911 Service Fund - \$60,000.00, 24-7 Sobriety Fund - \$4,547.00, M & P Relief Fund - \$14,500.00, and to set September 5, 2017, at 9:30 A.M. as the date and time for the first public hearing on adoption of the Provisional Budget as the 2018 Annual Budget. Motion carried.
