

COUNTY COMMISSION MEETING
IPSWICH, SOUTH DAKOTA
February 19, 2019

The Edmunds County Board of Commissioners met at 9:00 A.M. on February 19, 2019 at the county courthouse. Members present were: Robert Olson, Morris Grosz, Jerome Schaffner, Dennis Hoyle, and Timothy Thomas. Chairman Olson called the meeting to order at 9:00 A.M.

MINUTES APPROVED: Motioned by Schaffner, seconded by Hoyle to approve the minutes of the February 5, 2019 regular meeting. Motion carried.

JOINT POWERS AGREEMENT: Motioned by Schaffner, seconded by Grosz to approve and allow the chairman to sign the joint powers agreement, between Edmunds County and Union Township, for the rental of county blade/motor grader, snow removal equipment and an operator, from February 1, 2019 to January 31, 2020. Motion carried.

PLAT APPROVED: Motioned by Thomas, seconded by Schaffner to approve the following resolution: Be it resolved, by the Edmunds County Board of Commissioners, that the following plat, having been examined is hereby approved in accordance with the provisions of SDCL of 1967, Chapter 11-3, and any amendments thereof: Plat of WEB Water Tank Addition in the SW¼ of Section 23, 123-70, in Edmunds County, South Dakota. 
