The Edmunds County Board of Commissioners met at 9:00 A.M. on October 22, 2019 at the county courthouse. MINUTES APPROVED: Motioned by Hoyle, seconded by Schaffner to approve the minutes of the October 8, 2019 regular meeting. Motion carried.

Motion carried.

LIQUOR LICENSES: Motioned by Grosz, seconded by Thomas to approve the 2020 Retail On-Sale Liquor Licenses in the names of; Bowdle Golf Club, The Crossing LLC, Eagle Bar LLC, and The Wakeside Bar & Grill LLC, and to approve the 2020 Package Off-Sale Liquor in the name of The M Station. Motion carried.


