COVID-19 PANDEMIC: Motioned by Grosz, seconded by Thomas to adopt a policy to continue public service with limited public access to the Courthouse. In the interest of public health, county business will be primarily conducted by phone, fax or email. Five yes votes, motion carried.

JOINT POWERS AGREEMENTS: Motioned by Schaffner, seconded by Hoyle to approve and allow the chairman to sign the joint powers agreements, between Edmunds County and the Townships of Bowdle, Cloyd Valley, Hosmer, and Hudson for the rental of county blade/motor grader, snow removal equipment and an operator, and between Edmunds County and Bowdle Township for the rental of county spray equipment and one Edmunds County highway employee, all from March 5, 2020 to March 4, 2021. Five yes votes, motion carried.

- **RESOLUTION WEB WATER:** Angie Hammrich and Rod Tobin, WEB Water, were on conference call, for discussion on the resolution. The resolution was introduced by Commissioner Grosz, who moved its adoption: Resolution #2020-3-1, granting WEB Water Development Association authority to place, construct, maintain and operate its water pipeline system within Edmunds County for an additional 20 years. A complete copy of the resolution is on file in the Edmunds County Auditor's Office. Motion to adopt the resolution was seconded by Thomas. Roll call vote: Olson yes, Grosz yes, Schaffner yes, Hoyle yes, Thomas yes. Resolution adopted.
- **SURPLUS PROPERTY:** Motioned by Schaffner, seconded by Grosz to declare Lots 4-9 Block 8 & Lots 7-9 Block 9, Bolds Addition Ipswich as surplus county property and to approve and allow the chairman to sign the quit claim deed which transfers the same to the City of Ipswich. Five yes votes, Motion carried.
- **EXECUTIVE SESSION:** Motioned by Thomas, seconded by Grosz to enter into executive session at 10:20 A.M., according to SDCL 1-25-2(1). Five yes votes, motion carried. Executive session declared over at 10:24 A.M.
