Hutson as seasonal part-time assistant in the 4-H Department, at a salary of \$9.30 per hour, effective May 20, 2020 through August 14, 2020. The county will be reimbursed by the Edmunds County 4-H Leaders Association. Motion carried.
- **JOINT POWERS AGREEMENT:** Motioned by Grosz, seconded by Thomas to approve and allow the chairman to sign the joint powers agreement between Edmunds County and the City of Bowdle for the rental of county spray equipment and one Edmunds County highway employee, for the purpose of spraying mosquitoes, for the year of 2020. Motion carried.
- **TRANSFER CASH:** Motioned by Hoyle, seconded by Schaffner to make a budgeted transfer of \$750,000.00 cash from the General Fund to the County Road & Bridge Fund and a budgeted transfer of \$45,000.00 cash from the General Fund to the Emergency Management Fund. Motion carried.
