The Edmunds County Board of Commissioners met at 9:00 A.M. on March 2, 2021 at the county courthouse. NECOG AGREEMENT: Allison Kiesz, Northeast Council of Governments, met with the Board to discuss the need and time frame for updating the county's emergency response plans. Motioned by Preszler, seconded by Grosz, to approve and allow the Chairman to sign the agreement with the Northeast Council of Governments for the purpose of assistance in completing the Edmunds County Pre-Disaster Mitigation Plan. Motion carried.

PROPERTY PURCHASE: Motioned by Thomas, seconded by Preszler to purchase Lots 1-4, Block 20, Original Plat to Ipswich from Christopher and Jennifer Simon in the amount of \$20,000.00. Motion carried.

RIGHT OF WAY OCCUPANCY: Motioned by Thomas, seconded by Grosz to approve and authorize the chairman to sign the application for Right of Way Occupancy, with FEM Electric Association Inc to install electric cable under Edmunds County Highway #4, in Section 34, Township 124-70. Motion carried.

EXECUTIVE SESSION: Motioned by Thomas, seconded by Schaffner to enter into executive session at 10:30 A.M., according to SDCL 1-25-2(1). Motion carried. Executive session declared over at 11:35 A.M.



Motion carried
