MINUTES APPROVED: Motioned by Schaffner, seconded by Preszler to approve the minutes of the January 19, 2021 Weed & Pest Board Meeting. Motion carried.

WEED CONTROL: Michael Jager, Edmunds County Weed Supervisor, discussed personnel and the weed control plan for 2021 in Edmunds County. Supervisor Jager assured the Board that

- Deputy Weed Supervisor, Ryan Schlechter, would do a much better job than last year, be out spraying early in the mornings, and also spray mosquitoes when requested.
- Motioned by Grosz, seconded by Preszler to adjourn the weed meeting at 10:15 A.M. Motion carried.
- COURTHOUSE HOURS: Motioned by Preszler, seconded by Schaffner to close the Edmunds County Courthouse from 7:00 a.m. to 1:00 p.m. on Thursday April 15th to allow employees to attend the funeral of Robert Olson. Motion carried.
- **DISCUSSION:** Julie Johnson met with the Board and gave an update on the progress of the Mina Lake Spillway repair project scheduled to begin this summer.
- **EMERGENCY MANAGEMENT:** The Board reviewed information regarding updates on the progress of the Edmunds County Disaster Mitigation Plan. A planning meeting was held on March 23, 2021 in Bowdle. The next meeting will be held in Roscoe on May 3, 2021, at 8:00 p.m. at the fire hall. This is a countywide meeting open to the public for any comments or information about possible mitigation projects needed throughout the county.
- **HEALTH INSURANCE:** Motioned by Schaffner, seconded by Preszler to approve and allow the vice-chairman to sign the Associated School Boards of South Dakota Health Benefits Fund Participation Agreement, with the South Dakota School District Benefit Fund, to provide health insurance for Edmunds County employees, offering \$1,000 and \$1,500 deductibles, effective July 1, 2021 through June 30, 2022. Motion carried.
- **JOINT POWERS AGREEMENTS:** Motioned by Grosz, seconded by Preszler to approve and allow the vice-chairman to sign the joint powers agreements, between Edmunds County and the Townships of Bowdle, Hosmer, Ipswich and Modena for the rental of county blade/motor grader, snow removal equipment and an operator. Motion carried.
- **LIQUOR LICENSE:** Motioned by Preszler, seconded by Schaffner to approve the 2021-2022 On-Off Sale Malt Beverage and On-Off Sale SD Farm Wines License renewal in the name of The Wakeside Bar & Grill LLC. Motion carried.
 - Vickie Kitchell was present for the liquor license transfer hearing. Motioned by Grosz, seconded by Preszler to approve the 2021 Retail On-Sale Liquor License transfer from Eagle Bar LLC to Myran Properties LLC, Huber's Outlot 1 in the NE¼ of Section 29, Township 123-67. Motion carried.
- **RIGHT OF WAY OCCUPANCY:** Motioned by Schaffner, seconded by Preszler to approve and authorize the vice-chairman to sign the applications for Right of Way Occupancy, with FEM Electric Association Inc to install electric cable under Edmunds County Highway #24, in Section 3, Township 121-66, and under Edmunds County Highway #15, in Section 10, Township 121-66. Motion carried.
