- **GRANT APPLICATION:** Motioned by Preszler, seconded by Thomas to authorize the Edmunds County Sheriff to apply for a 50/50 grant through the South Dakota Unified Judicial System Court Security Grant Program, for a new courthouse security camera system, in the amount of \$25,558.87. Motion carried.
- **JOINT POWERS AGREEMENTS:** Motioned by Thomas, seconded by Schaffner to approve and allow the chairman to sign the joint powers agreements, between Edmunds County and the Townships of Cloyd Valley, Glover, Hudson and Montpelier for the rental of county blade/motor grader, snow removal equipment and an operator. Motion carried.
