IPSWICH, SOUTH DAKOTA

July 20, 2021

The Edmunds County Board of Commissioners met at 9:00 A.M. on July 20, 2021 at the county courthouse. Members present were: Dean Mehlhaff, Morris Grosz, Jerome Schaffner, Chad Preszler, and Timothy Thomas. Chairman Thomas called the meeting to order at 9:00 A.M. MINUTES APPROVED: Motioned by Grosz, seconded by Mehlhaff to approve the minutes of the July 6, 2021 regular meeting. Motion carried.

COUNTY VEHICLE FLEET: Discussion and more information was presented on Quartix Vehicle Trackers that will be installed in all Edmunds County licensed vehicles.

CREDIT CARD: Motioned by Grosz, seconded by Schaffner to allow Barbara A. Schaefer, Veterans Service Officer, to use a county credit card for county purchases only. Motion carried.

EMPLOYEE RESIGNATION: Motioned by Preszler, seconded by Mehlhaff to accept the resignation of Mandy N. Schaible, Sheriff's department dispatcher, effective July 22, 2021. Motion carried.

HIGHWAY SYSTEM: Motioned by Schaffner, seconded by Grosz to approve and allow the chairman to sign the agreement, between Edmunds County and the South Dakota Department of Transportation, amending agreement #716847, Highway Infrastructure Program Fund use and allocation. Motion carried.

PLAT APPROVED: Motioned by Schaffner, seconded by Preszler to approve the following resolution: Be it resolved, by the Edmunds County Board of Commissioners, that the following plat, having been examined is hereby approved in accordance with the provisions of SDCL of 1967, Chapter 11-3, and any amendments thereof; Plat of Johnson Third Addition in the S½ of Section 23, 123-66, in Edmunds County, South Dakota. Motion carried.


