- **DISCUSSION:** John Villbrandt with the SD Department of Transportation met with the Board to give an update on next year's reconstruction of State Highway 47 and the related possible impacts to Edmunds County Highways 1 and 10.
- **CAMERA SYSTEM:** Motioned by Mehlhaff, seconded by Grosz to designate the Sheriff to have application access to the complete Edmunds County Courthouse video surveillance system and to designate the Commissioner Chairman and Auditor to have application access to surveillance system less the courthouse basement level. Motion carried.
- **COUNTY VEHICLE TRACKERS:** Motioned by Mehlhaff, seconded by Preszler to designate the Sheriff and States Attorney to have application access to vehicle trackers for the four sheriff patrol vehicles. Motion carried.
 - Motioned by Preszler, seconded by Mehlhaff to designate the Commissioner Chairman, Auditor, and Highway Superintendent to have application access to all county vehicle trackers except the four sheriff patrol vehicles. Motion carried.
- **DRAINAGE:** John Carrels, Dustin Usselman, and Michael Gutenkauf, IMEG Engineering Corp, met with the Board to discuss water flow along County Road #31. Motioned by Preszler, seconded by Schaffner to place an 18-inch culvert in the new approach that will be installed across from 147 West Lake Drive, and to place a new additional 24-inch culvert at a skew under County Road #31. Motion carried.
- **EMPLOYEE STEP:** Motioned by Preszler, seconded by Mehlhaff to increase the salary of Zachary R. Sahli, dispatcher, to \$19.16 per hour, effective September 1, 2021. Motion carried.
- **ORDINANCE MARIJUANA:** Motioned by Grosz, seconded by Schaffner, to approve the first reading of Edmunds County Ordinance No. 2021-9-2, An ordinance creating licensing provisions for cannabis establishments. The second reading, for Ordinance No. 2021-9-2, will be on

September 21, 2021. Roll call vote: Mehlhaff – yes, Grosz – yes, Schaffner – yes, Preszler – yes, Thomas – yes. Motion carried.

ZONING: Edmunds County Commissioners continued the review and rewrite of the Edmunds County Planning and Zoning Ordinances, and the Comprehensive Plan for Edmunds County. Eric Senger of Northeast Council of Governments, Brittney Casey, and Sandra Northrop were present for the update discussion.

EXECUTIVE SESSION: Motioned by Preszler, seconded by Schaffner to enter into executive session at 12:05 P.M., according to SDCL 1-25-2(1). Motion carried. Executive session declared over at 12:10 P.M.
