 - MINUTES APPROVED: Motioned by Grosz, seconded by Preszler to approve the minutes of the December 7, 2021 Weed & Pest Board Meeting. Motion carried.
 - WEED CONTROL: Michael Jager, Edmunds County Weed Supervisor, reported on the Weed & Pest conference, which he attended, and discussed the purchase of chemical and the weed control plan for 2022 in Edmunds County.
 - Motioned by Preszler, seconded by Schaffner to adjourn the weed meeting at 10:35 A.M. Motion carried.
- AIRCRAFT: Motioned by Grosz, seconded by Preszler to approve and allow the chairman to sign the Permit Application allowing Wilbur-Ellis Air LLC, to operate, take off, or land aircraft on Edmunds County roads for the year of 2022, for the purpose of servicing said aircraft in preparation for aerial application of chemical or fertilizer materials. The aircraft shall be operated at their own risk, the county will assume no liability, proof of liability insurance has been filed with the Edmunds County Auditor and the aircraft operator must follow all Federal and State laws and regulations. Motion carried.
- **BIDS CULVERTS:** Motioned by Preszler, seconded by Grosz to purchase culverts and bridge material off the bid which was awarded to True North Steel, at the January 11, 2022, Beadle County Commission meeting. Motion carried.
- **EMPLOYEES:** Motioned by Preszler, seconded by Mehlhaff to increase the salary of Jason R. Shaykett, highway maintenance, to \$20.62 per hour, effective March 1, 2022. Motion carried.

- Motioned by Grosz, seconded by Mehlhaff to hire Dale A. Preszler as Foreman in the Highway Department, at a salary of \$21.62 per hour, effective March 1, 2022. Voice vote; majority yes, Preszler abstained. Motion carried.
