- **PLAT APPROVED:** Motioned by Preszler, seconded by Mehlhaff to approve the following resolution: Be it resolved, by the Edmunds County Board of Commissioners, that the following plat, having been examined is hereby approved in accordance with the provisions of SDCL of 1967, Chapter 11-3, and any amendments thereof; Plat of Schumacher Addition in the W¹/₂ of the SW¹/₄ of Section 3, 124-71, in Edmunds County, South Dakota. Motion carried.
