- **CARBON DIOXIDE PIPELINE:** Trevor Jones, Summit Carbon Solutions Regulatory Affairs Manager, met with the Board to give updates concerning the proposed carbon dioxide pipeline and to discuss upcoming Road Crossing Permits.
- **EMPLOYEES:** Motioned by Geditz, seconded by Preszler to accept the Sheriff's termination of Daniel J. Hardison, Deputy Sheriff, effective June 1, 2023. Motion carried.
  - Motioned by Preszler, seconded by Mehlhaff to approve the Sheriff's hiring of April A. Bollinger-Bryant, as full-time dispatcher to work in the Sheriff's Department, effective July 1, 2023, at a salary of \$19.91 per hour. Motion carried.
- **JOINT POWERS AGREEMENT:** Motioned by Preszler, seconded by Grosz to approve and allow the Chairman to sign the Joint Powers Agreement between Edmunds County and the City of Bowdle, for the rental of county spray equipment and one Edmunds County highway employee at the rate of \$80.00 per hour, for the purpose of spraying mosquitoes within the City of Bowdle, for the year of 2023. Motion carried.
- **SHERIFF'S VEHICLE:** Motioned by Mehlhaff, seconded by Preszler to purchase one used 2019 Chevrolet Tahoe Police vehicle, including Setina K-9 insert, from O'Brien County Iowa, in the amount of \$28,000.00, for the Edmunds County Sheriff's Department. Motion carried.

- **SUPPLEMENT BUDGET:** Motioned by Grosz, seconded by Geditz to supplement the Sheriff's Budget, in the amount of \$7,637.61, with Highway Safety Enforcement grant money, and in the amount of \$15,000.00, with South Dakota Drug Control Funds, both per SDCL 7-21-20.1. Motion carried.
- **SURPLUS PROPERTY:** Motioned by Geditz, seconded by Preszler to declare 2.41 ton of scrap iron as surplus county property and allow the same to be sold to Meyers Tractor Salvage LLC. Motion carried.
- **TRAVEL AUTHORIZATIONS:** Motioned by Geditz, seconded by Mehlhaff to allow Brittney Duvall and Sandra Northrop to attend the Ultra Inc. Software Users Meeting in Huron on July 26<sup>th</sup>, and allow Diane Geditz, Patricia Nigg, Dionne Olson, and Keith Schurr, to attend the Ultra Inc.
