July 25, 2023

The Edmunds County Board of Commissioners met at 9:00 a.m. on July 25, 2023 at the county courthouse. Members present were: Dean Mehlhaff, Morris Grosz, Micheal J. Geditz, Chad Preszler, and Timothy Thomas. REGISTER OF DEEDS: Motioned by Preszler, seconded by Mehlhaff to accept the Register of Deeds Statement of Fees for the month of June 2023 in the amount of \$5,701.90. Motion carried.

EMERGENCY/DISASTER RESOLUTION: The following resolution was introduced by Commissioner Preszler, who moved its adoption: Resolution #2023-7-3, declaring Emergency/Disaster conditions to exist in Edmunds County. The motion was seconded by Mehlhaff. Roll call vote: Mehlhaff - yes, Grosz - yes, Geditz - yes, Preszler - yes, Thomas - yes. Resolution adopted.

WHEREAS, Edmunds County, South Dakota, has suffered severe damage, brought on by excess rain and spring snow melt that produced heavy run off and flooding, that has impacted the county so as to request a declaration for a Spring flood emergency commencing on April 9, 2023; and

WHEREAS, Edmunds County, Edmunds County Townships and other public entities have flooding, causing damage to public infrastructure; and

WHEREAS, the Edmunds County Board of Commissioners and local municipalities are responsible for keeping streets and roads open, especially school bus routes, delivery routes, and for service and emergency vehicles; and

WHEREAS, the county, townships and cities have committed all available equipment, and taken all possible action within the jurisdictional boundaries to combat and alleviate the emergency/disaster. Local resources are no longer adequate to cope with the situation.

NOW THEREFORE BE IT RESOLVED, the Board of County Commissioners of Edmunds County, South Dakota declare a flood emergency, and

BE IT FURTHER RESOLVED, We, the Board of Commissioners of Edmunds County respectfully petition the Governor of the State of South Dakota to declare an emergency/disaster to exist in the County of Edmunds.

CREDIT CARD: Motioned by Preszler, seconded by Mehlhaff to allow Daniel D. Braun, Deputy Sheriff, to use a county credit card for county purchases only. Motion carried.

HIGHWAY PURCHASE – BROOM: Motioned by Preszler, seconded by Mehlhaff to purchase one new 2023 Superior Broom SM74J from RDO Equipment, as per Sourcewell bid, in the amount of \$79,927.28 for the Edmunds County Highway Department. Motion carried.

JAIL: Motioned by Geditz, seconded by Preszler to approve and allow the chairman to sign the Jail Agreement, with Beadle County, to provide housing for Edmunds County prisoners at a rate of \$95.00 adult per day and \$200.00 juvenile per day in the Beadle County facility. Motion carried.

PROVISIONAL BUDGET: The Board of Commissioners began the review process for the Edmunds County 2024 Provisional Budget.

EXECUTIVE SESSION: Motioned by Mehlhaff, seconded by Preszler to enter into executive session at 10:30 a.m., according to SDCL 1-25-2(3). Motion carried. Executive session declared over at 10:40 a.m.

MEETINGS SCHEDULED: The next regular Edmunds County Commissioner Meetings will be held at 9:00 a.m. on August 8th and August 22nd.

ADJOURN: Motioned by Grosz, seconded by Geditz to adjourn at 11:00 a.m. Motion carried.
