NURSE – OFFICE OF PUBLIC HEALTH ALLIANCE: Melanie Kaiser, Community Health Nurse, met with the Board to give a report on services provided by the health department, and discussed the Public Health Contract. Motioned by Grosz, seconded by Mehlhaff to approve and allow the chairman to sign the Office of Public Health Alliance Contract between South Dakota Department of Health, Bowdle Hospital, and Edmunds County, in the amount of \$40,000.00, to provide community health services for the citizens of Edmunds County, effective June 1, 2023 through May 31, 2024. Motion carried.

PLATS APPROVED: Motioned by Mehlhaff, seconded by Geditz to approve the following resolution:
Be it resolved, by the Edmunds County Board of Commissioners, that the following plats, having been examined are hereby approved in accordance with the provisions of SDCL of 1967, Chapter 11-3, and any amendments thereof; plat of Miller Addition in the NW¼ of Section 24, 123-66, plat of Palmer Addition in the NE¼ of Section 28, 122-66, and plat of Lot 1 of the Preszler 1st Addition in the SE¼ SW¼ of Section 15, 123-71, all in Edmunds County, South Dakota. Motion carried.
