**WEED & PEST BOARD MEETING:** Motioned by Mehlhaff, seconded by Preszler to open the weed meeting at 9:10 a.m. Motion carried.

MINUTES APPROVED: Motioned by Grosz, seconded by Geditz to approve the minutes of the August 22, 2023 Weed & Pest Board Meeting. Motion carried.

WEED CONTROL: Michael Jager, Edmunds County Weed Supervisor, discussed the mosquito spraying, weed control, chemicals used this season, and plans for 2024 in Edmunds County. Motioned by Grosz, seconded by Geditz to adjourn the weed meeting at 9:30 a.m. Motion carried.

- **CARBON DIOXIDE PIPELINE:** Aaron Eldridge, Summit Carbon Solutions Project Manager, met with the Board to give updates concerning the proposed carbon dioxide pipeline and project status.
- **EMPLOYEES:** Motioned by Preszler, seconded by Mehlhaff to approve the Sheriff's hiring of Brooke M. Jensen, as full-time dispatcher to work in the Sheriff's Department, effective September 11, 2023, at a salary of \$19.91 per hour, with a \$0.50 per hour raise on December 16, 2023, and a \$0.50 per hour raise on March 16, 2024. Motion carried.
  - Motioned by Mehlhaff, seconded by Preszler to increase the salary of April A. Bollinger-Bryant, dispatcher, to \$20.41 per hour, effective October 1, 2023. Motion carried.
- PLATS APPROVED: Motioned by Grosz, seconded by Geditz to approve the following resolution: Be it resolved, by the Edmunds County Board of Commissioners, that the following plats, having been examined are hereby approved in accordance with the provisions of SDCL of 1967, Chapter 11-3, and any amendments thereof; Mina Sixth Parkside Estates in the S½SW¼ of Section 24, 123-66, and plat of MJK Dream Hunt Addition in the NE¼ of Section 21, 121-73, both in Edmunds County, South Dakota. Motion carried.
- **INDIGENT BURIAL:** Motioned by Grosz, seconded by Mehlhaff to set the County indigent burial and funeral assistance at \$2,000.00 and to allow only for a cremation. Motion carried.

- **2024 BUDGET:** The following resolution was introduced by Commissioner Grosz, who moved its adoption: Resolution #2023-9-1, Adoption of the 2024 Annual Budget for Edmunds County. The motion to adopt the resolution was seconded by Mehlhaff.
  - Whereas, (7-21-5 thru 13), SDCL provides that the Board of County Commissioners shall each year prepare a Provisional Budget of all contemplated expenditures and revenues of the County and all its institutions and agencies for such fiscal year and,
  - Whereas, the Edmunds County Board of Commissioners did prepare a Provisional Budget and cause same to be published by law, and
  - Whereas, due and legal notice has been given, to the meeting of the Edmunds County Board of Commissioners, for the consideration of such Provisional Budget and all changes, eliminations and additions have been made thereto.
  - NOW THEREFORE BE IT RESOLVED, That such Provisional Budget as amended and all its purposes, schedules, appropriations, amounts, estimates and all matters therein set forth, SHALL BE APPROVED AND ADOPTED AS THE ANNUAL BUDGET OF THE APPROPRIATION AND EXPENDITURES FOR Edmunds County, South Dakota, and all its institutions and agencies for calendar year beginning January 1, 2024, and ending December 31, 2024, and the same is hereby approved and adopted by the Board of County Commissioners of Edmunds County, South Dakota, this 19<sup>th</sup> day of September, 2023. The Annual Budget so adopted is available for public inspection during normal business hours at the office of the county auditor Edmunds County, South Dakota. Taxes are levied by Edmunds County for the year January 1, 2024, through December 31, 2024, in the amount of \$3,489,296.00 which sets the 2023 Edmunds County Mill Levy at 2.456 dollars per \$1,000.00 of valuation, for taxes payable in 2024.

Motion carried.
