- **WEED & PEST BOARD MEETING:** Motioned by Geditz, seconded by Mehlhaff to open the weed meeting at 10:15 a.m. Motion carried.
 - MINUTES APPROVED: Motioned by Grosz, seconded by Mehlhaff to approve the minutes of the September 19, 2023 Weed & Pest Board Meeting. Motion carried.

WEED CONTROL: Michael Jager, Edmunds County Weed Supervisor, discussed the mosquito spraying, weed control, weed & pest grants, and plans for 2024 in Edmunds County.

Motioned by Grosz, seconded by Mehlhaff to adjourn the weed meeting at 10:40 a.m. Motion carried.

- AMERICAN RESCUE PLAN: Motioned by Preszler, seconded by Geditz, to designate the use of \$100,000.00 Local Assistance and Tribal Consistency Fund of the American Rescue Plan Act funds received as capital expenditures for County purchase of public safety equipment two new equipped sheriff vehicles, that were previously purchased. Motion carried.
- **BRIDGES:** Michael Gutenkauf, IMEG Engineering Corporation, presented the Board with the 2023 Edmunds County Bridge Inspection Report.

- **EXECUTIVE SESSION:** Motioned by Geditz, seconded by Preszler to enter into executive session at 9:55 a.m., according to SDCL 1-25-2(3). Motion carried. Executive session declared over at 10:10 a.m.
- **HIGHWAY TRUCK:** Motioned by Preszler, seconded by Mehlhaff to authorize the purchase one new 2025 Western Star model 49X semi-tractor, from Floyds Truck Center, as per Sourcewell bid, in the amount of \$164,894.00. Motion carried.
- **HOLIDAY:** Motioned by Geditz to declare Tuesday, December 26, 2023, a holiday for county employees and close the courthouse. Motion died due to lack of a second.
- **NECOG AGREEMENT:** Motioned by Preszler, seconded by Mehlhaff, to approve and allow the Chairman to sign the Joint Cooperative Agreement with the Northeast Council of Governments for the year of 2024, in the amount of \$8,657.71, for the purpose of providing planning, technical aid, and assistance capabilities to its membership and other units of local governments. Motion carried.
- PLAT APPROVED: Motioned by Grosz, seconded by Mehlhaff to approve the following resolution: Be it resolved, by the Edmunds County Board of Commissioners, that the following plat, having been examined is hereby approved in accordance with the provisions of SDCL of 1967, Chapter 11-3, and any amendments thereof; Plat of G T Second Subdivision in the SW¼ of Section 23, 123-66, Edmunds County, South Dakota. Motion carried.
- **QUIT CLAIM DEED:** Motioned by Mehlhaff, seconded by Preszler to approve and allow the chairman to sign the quit claim deed which transfers, via right of redemption, Lot 5 of Block 3 of Turners Addition to the City of Ipswich, to David, Randolph, and Joshua Schumacher. Motion carried.
- **RESOLUTION FINANCING NEW COUNTY FACILITY:** The following resolution was introduced by Commissioner Preszler, who moved its adoption: Resolution #2023-12-1, A Resolution Authorizing a Special Election for the purpose of issuing General Obligation Bonds for construction of a new Jail, Dispatch Center, and Sheriff's Office within Edmunds County, South Dakota. The motion to adopt the resolution was seconded by Geditz. Roll call vote: Mehlhaff – yes, Grosz – yes, Geditz – yes, Preszler – yes, Thomas - yes. Resolution adopted.
 - BE IT ORDAINED BY EDMUNDS COUNTY, that a new jail, dispatch center, and sheriff's office is vital to the safety and welfare of Edmunds County residents.
 - BE IT ORDAINED BY EDMUNDS COUNTY, that a special election for the purpose of issuing general obligation bonds in an amount not to exceed \$7,400,000.00 shall be held at a date and time as allowed by law.
 - BE IT ORDAINED BY EDMUNDS COUNTY, that said general obligation bonds in an amount not to exceed \$7,400,000.00 shall only be used for the construction of a new jail, dispatch center, and sheriff's office.
 - BE IT FURTHER ORDAINED BY EDMUNDS COUNTY, that a special election for the purpose of issuing general obligation bonds in an amount not to exceed \$7,400,000.00 for the project described herein shall be held on March 12, 2024.

RESOLUTION – HAZARDOUS WASTE PIPELINE ZONING MORATORIUM: The following

resolution was introduced by Commissioner Geditz, who moved its adoption: Resolution #2023-

12-2, A Resolution Establishing a Temporary Moratorium on the Issuance of Conditional Use

Permits and Building Permits on Hazardous Waste Pipelines within Edmunds County, South

- BE IT ORDAINED BY EDMUNDS COUNTY, that a study, development of a comprehensive plan, and zoning ordinances and policies need to be developed in relation to hazardous waste pipelines to protect the public health, safety, and general welfare;
- BE IT FURTHER ORDAINED BY EDMUNDS COUNTY, that a moratorium shall be in place for a period of 90 days, unless removed prior thereto or extended as provided by SDCL 11-2-10, on the construction of any hazardous waste pipelines within the unincorporated areas of Edmunds County.

CONTINGENCY TRANSFER: Motioned by Grosz, seconded by Mehlhaff to transfer \$35,000.00 from

the 2023 county contingency budget to the road & bridge budget. Motion carried.

MEETINGS SCHEDULED: The next regular Edmunds County Commissioner Meetings will be held at 9:00 a.m. on January 2nd and January 23rd.
