IPSWICH, SOUTH DAKOTA

May 21, 2024

The Edmunds County Board of Commissioners met at 9:00 a.m. on May 21, 2024 at the county courthouse. Members present were: Dean Mehlhaff, Morris Grosz, Micheal J. Geditz, Chad Preszler, and Timothy Thomas. Chairman Thomas called the meeting to order at 9:00 a.m. Others present for portions of the meeting were: Michael Jager, Dale Preszler, and Jonathan Waldner.

MINUTES APPROVED: Motioned by Grosz, seconded by Mehlhaff to approve the minutes of the May 7, 2024 regular meeting. Motion carried.

BUILD DAKOTA SCHOLARSHIP: Motioned by Geditz, seconded by Preszler to approve and allow the chairman to sign the two-year, \$11,000.00 Build Dakota Scholarship Agreement between Edmunds County, Lake Area Technical College and Chet W. Peterson. Motion carried.

EMPLOYEES HIRED: Motioned by Preszler, seconded by Mehlhaff to hire William G. Osborne as full-time employee in the Highway Department, effective May 22, 2024, at a salary of \$22.16 per hour. Voice vote; majority - yes, Grosz – no. Motion carried.

Motioned by Geditz, seconded by Preszler to hire Ava E. Davis as seasonal part-time assistant in the 4-H Department, at a salary of \$11.20 per hour, effective June 3, 2024 through August 16, 2024. The county will be reimbursed by the Edmunds County 4-H Leaders Association. Motion carried.

Motioned by Preszler, seconded by Mehlhaff to hire Morgan C. Weisser as seasonal part-time assistant in the 4-H Department, at a salary of \$15.00 per hour, effective May 21, 2024 through August 16, 2024. The county will be reimbursed by the Edmunds County 4-H Leaders Association. Motion carried.

GROW SOUTH DAKOTA: Collin Fitz from GROW South Dakota met with the Board to inform them of the different programs offered through GROW SD and gave a report on where funds have been spent in Edmunds County for the year of 2023.

LAW ENFORCEMENT CENTER: Troy Doeden, Jason Flack - Comstock Construction Inc, Tracy Hutson, Corey Johnson - GA Johnson Construction, and Adam Kuehl – HMN Architects Inc, were present for opening the Qualifications and Proposals for Construction Management as Constructor Services for the new Edmunds County Law Enforcement Center. Qualifications and Proposals were received from; Comstock Construction Inc, GA Johnson Construction Inc, Huff Construction, and Kyburz-Carlson Construction. The Board and Sheriff Waldner reviewed the qualifications, proposals, current design plans, and construction scheduling.

Motioned by Preszler, seconded by Mehlhaff to interview Corey Johnson, GA Johnson Construction Inc at the May 29th Commission meeting. Motion carried.
