MINUTES APPROVED: Motioned by Grosz, seconded by Mehlhaff to approve the minutes of the April 23, 2024 Weed & Pest Board Meeting. Motion carried.

WEED CONTROL: Michael Jager, Edmunds County Weed Supervisor, discussed weed control progress for 2024, mosquito spray equipment repairs, and the weed control plan for 2025 in Edmunds County.

Motioned by Mehlhaff, seconded by Geditz to adjourn the weed meeting at 9:40 a.m. Motion carried.

- **BRIDGE GRANTS:** Motioned by Mehlhaff, seconded by Preszler to approve and allow the chairman to sign the Bridge Improvement Grant Agreements, between Edmunds County and the South Dakota Department of Transportation, for Preliminary Engineering on Edmunds County bridge projects BRO 8023 25-1 09XW, 80% grant amount \$36,000 and project BRO 8023 25-2 09XX, 80% grant amount \$43,100. Motion carried.
- **EMPLOYEE HIRED:** Motioned by Mehlhaff, seconded by Grosz to approve the Auditor's hiring of Melissa R. Kleffman, as full-time Deputy Auditor, effective October 1, 2024, at a salary of \$46,800.00 per year with a \$500.00 per year step increase on April 1, 2025. Motion carried.
- **TRAVEL AUTHORIZATIONS:** Motioned by Preszler, seconded by Geditz to allow Andrea Carlson and Jonathan Waldner to attend the SD Sheriff's Association Fall Conference in Watertown on September 30<sup>th</sup> thru October 3<sup>rd</sup>, and allow Kyle Couchey to attend the Drug Recognition Expert training in Sioux Falls on October 3<sup>rd</sup> 4<sup>th</sup>. Motion carried.
- 2025 BUDGET: Motioned by Mehlhaff, seconded by Geditz to amend the Provisional Budget by making the following changes: Increase General Fund Expenditure Budgets; Sheriff (code #211) from \$1,007,973 to \$1,012,973; Senior Citizens (code #525) from \$7,500 to \$8,000; and to increase General Fund Revenue Budgets; Cash Balance Applied from \$1,374,875 to \$1,380,664; Less 5% (SDCL 7-21-18) from \$264,850 to \$265,139; and to increase the following County Road & Bridge Revenue Budget; Cash Balance Applied from \$661,411 to \$662,338; and decrease the following County Road & Bridge Revenue Budget; County Road & Bridge Tax Levy (code 311) from \$743,000 to \$742,073; and to increase the following Debt Service Law Enforcement Center Budgets; Debt Service Interest (code 800) from \$330,000 to \$359,000; Property Tax Levy (code 108) from \$524,316 to \$540,105; Less 5% (SDCL 7-21-18) from \$26,316 to \$27,105; and decrease the following Debt Service Law Enforcement Center Budget; Debt Service Principal (code 401) from \$170,000 to \$156,000; and approve the following Resolution #2024-9-1.
  - Whereas, (7-21-5 thru 13), SDCL provides that the Board of County Commissioners shall each year prepare a Provisional Budget of all contemplated expenditures and revenues of the County and all its institutions and agencies for such fiscal year and,
  - Whereas, the Edmunds County Board of Commissioners did prepare a Provisional Budget and cause same to be published by law, and
  - Whereas, due and legal notice has been given to the meeting of the Edmunds County Board of Commissioners, for the consideration of such Provisional Budget and all changes, eliminations and additions have been made thereto.
  - NOW THEREFORE BE IT RESOLVED, That such Provisional Budget as amended and all its purposes, schedules, appropriations, amounts, estimates and all matters therein set forth, SHALL BE APPROVED AND ADOPTED AS THE ANNUAL BUDGET OF THE APPROPRIATION AND EXPENDITURES FOR Edmunds County, South Dakota, and all its institutions and agencies for calendar year beginning January 1, 2025, and ending December 31, 2025, and the same is hereby approved and adopted by the Board of County Commissioners of Edmunds County,

South Dakota, this 10<sup>th</sup> day of September, 2024. The Annual Budget so adopted is available for public inspection during normal business hours at the office of the county auditor Edmunds County, South Dakota. Taxes are levied by Edmunds County for the year January 1, 2025, through December 31, 2025, in the amount of \$4,893,804.00 which sets the 2024 Edmunds County Mill Levy at 3.297 dollars per \$1,000.00 of valuation, for taxes payable in 2025.
