- The Edmunds County Board of Commissioners met at 9:00 a.m. on November 19, 2024 at the county courthouse. Members present were: Dean Mehlhaff, Morris Grosz, Micheal J. - **MINUTES APPROVED:** Motioned by Grosz, seconded by Preszler to approve the minutes of the November 7, 2024 regular meeting with the following correction: LAW ENFORCEMENT CENTER: Motioned by Preszler, seconded by Mehlhaff to accept the bids, including alternate #1, for the construction of the new Edmunds County Law Enforcement Center and Jail, GA Johnson Construction as Manager in the amount of \$8,393,671.00, with a current completion date of January 2026. Motion carried.
- **BRIDGES:** Michael Gutenkauf, IMEG Engineering Corporation, presented the Board with the 2024 Edmunds County Bridge Inspection Report.
- **EXECUTIVE SESSION:** Motioned by Preszler, seconded by Geditz to enter executive session at 9:20 a.m., according to SDCL 1-25-2(1). Motion carried. Executive session declared over at 9:35 a.m.
- **EMPLOYEES:** Motioned by Preszler, seconded by Geditz to approve the Sheriff's hiring of Lily C. Hohn, as full-time dispatcher to work in the Sheriff's Department, effective November 12, 2024, at a salary of \$21.21 per hour. Motion carried.
 - Motioned by Grosz, seconded by Mehlhaff to accept the resignation of Keith A. Schurr, Auditor, effective January 3, 2025. Motion carried.
 - Motioned by Preszler, seconded by Geditz to temporarily appoint Dionne M. Olson, as Edmunds County Auditor, effective January 3, 2025, at an annual salary of \$58,960.00, with a six-month probationary performance review period. Motion carried.
- LAW ENFORCEMENT CENTER: Motioned by Preszler, seconded by Mehlhaff to approve and allow the chairman to sign the contract with Geotek Engineering & Testing Services Inc. as geotechnical engineer to perform soil testing for the new Law Enforcement Center. Motion carried.

Motion carried.
- **POST-ELECTION AUDIT:** The Public Utilities Commissioner race and the Constitutional Amendment G question in Edmunds County Precinct Six were audited by the Edmunds County Post-Election Auditing Board on November 14, 2024. The PUC results were: Wilson 17, Oakes 5, Fiegen 114. Amendment G results were: Yes 39, No 106.
 - Motioned by Mehlhaff, seconded by Preszler to accept the Edmunds County primary post-election manual count audit results, which matched the November 5, 2024 election night machine count and the November 7, 2024 County canvass with 100% accuracy. Motion carried.

- **SUPPLEMENT BUDGET:** Motioned by Preszler, seconded by Mehlhaff to supplement the Sheriff's Budget, in the amount of \$24,659.85, with Highway Safety Enforcement grant money received, per SDCL 7-21-20.1. Motion carried.
