COUNTY COMMISSION MEETING

IPSWICH, SOUTH DAKOTA January 7, 2025

- The Edmunds County Board of Commissioners met at 9:00 a.m. on January 7, 2025 at the county courthouse. Members present were: Dean Mehlhaff, Micheal J. Geditz, Chad Preszler, Timothy Thomas and William Tweedy. Chairman Thomas called the meeting to order at 9:00 a.m. Others present for portions of the meeting were: Janel Brandt, Todd Brandt, Andrea Carlson, Michael Jager, Barbara Schaefer and Jonathan Waldner.
- **MINUTES APPROVED:** Motioned by Mehlhaff, seconded by Preszler to approve the minutes of the December 17, 2024 meeting. Motion carried.
- **CHAIRMAN:** The County Auditor called for nominations for Chairman. Dean Mehlhaff nominated Timothy Thomas as Chairman. Motioned by Geditz, seconded by Mehlhaff that nominations cease. Motion carried. Timothy Thomas was elected Chairman for the year of 2025.
- VICE-CHAIRMAN: The County Auditor called for nominations for Vice-Chairman. Timothy
 Thomas nominated Chad Preszler as Vice-Chairman. Motioned by Mehlhaff, seconded by
 Geditz that nominations cease. Motion carried. Chad Preszler was elected ViceChairman for the year 2025.
- **APPOINTMENTS:** The Chairman made the following appointments:

- **ELECTION:** Rent paid, to precinct polling places for each election, will be set at a maximum of \$200.00 per day for the year 2025. Election workers will be paid a flat amount of \$50.00 for attending election training and \$300.00 for working election day. Post-

Election Audit Board members shall receive a minimum of \$60.00 or \$17.50 per hour if their time exceeds 3.5 hours.

- **RESOLUTION WEIGHT & SPEED LIMIT ENFORCEMENT:** The following resolution was introduced by Commissioner Geditz, who moved its adoption: Resolution #2025-1-1, establishing the enforcement of weight & speed limits in Edmunds County. The motion to adopt the resolution was seconded by Mehlhaff. Roll call vote: Mehlhaff yes, Geditz yes, Preszler yes, Thomas yes, Tweedy yes. Resolution adopted.
 - WHEREAS, the County of Edmunds, South Dakota, is responsible for the maintenance of certain highways under its jurisdiction, and
 - WHEREAS, the Edmunds County Board of Commissioners, desires to protect existing Edmunds County Highways, ultimately saving tax dollars, and
 - WHEREAS, said highways, by reason of seasonal climatic changes, will be seriously damaged or destroyed unless vehicle weight and speed restrictions are imposed.
 - NOW, THEREFORE, BE IT RESOLVED, that all county roads in Edmunds County will be under a 6 ton per axle load limit restriction and speed limit restrictions of 40 mph for trucks, effective at 12:01 A.M. on March 1, 2025, through 11:59 P.M. on April 30, 2025, or as posted.
 - BE IT FURTHER RESOLVED, that the County of Edmunds shall request and authorize the South Dakota Highway Patrol to enforce weight limitations and speed restrictions, as established by this resolution, on all Edmunds County roads.
 - BE IT FURTHER RESOLVED, that the penalty for the violation of the load restrictions shall be as set forth in SDCL 32-22-55.
- **JAIL:** Motioned by Preszler, seconded by Geditz to approve and allow the chairman to sign the Jail Agreements, with Beadle County, to provide housing for Edmunds County prisoners at a rate of \$105.00 adult per day and \$325.00 juvenile per day in the Beadle County facility and with Charles Mix County, to provide housing for Edmunds County prisoners at a rate of \$90.00 adult per day. Motion carried.
- **K-9 UNIT UPDATE:** Chad Preszler gave an update to the board that our K-9 Unit Grayz is now a certified drug dog.
- **QUIT CLAIM DEED SURPLUS PROPERTY:** Motioned by Mehlhaff, seconded by Geditz to declare the West 203' of the North 163' of Lot A in the SW¼ Section 22, Bowdle Township 123-73 as surplus county property and to approve and allow chairman to sign the quit claim deed which transfers the same to Todd A and Janel C Brandt. Motion carried.

EXECUTIVE SESSION: Motioned by Preszler, seconded by Geditz to enter into executive session at 10:03 a.m., according to SDCL 1-25-2(1). Motion carried. Executive session declared over at 10:51 a.m.

TRAVEL AUTHORIZATION: Motioned by Geditz, seconded by Preszler to allow all of the Highway employees to attend the Mining Safety and Health Administration Training in Aberdeen on February 18, 2025 or March 11, 2025. Motion carried.

MEETINGS SCHEDULED: The next regular Edmunds County Commissioner Meetings will be held at 9:00 a.m. on January 21st and February 4th.
