RESOLUTION – EDMUNDS COUNTY BRIDGE REINSPECTION PROGRAM RESOLUTION

FOR USE WITH SDDOT RETAINER CONTRACTS: The following resolution was introduced by Commissioner Preszler, who moved its adoption: Resolution #2025-1-2, establishing IMEG Engineering Corporation as Consulting Engineers for the required 2025 Edmunds County bridge inspection work. The motion to adopt the resolution was seconded by Mehlhaff. Roll call vote: Mehlhaff - yes, Geditz – absent, Preszler - yes, Thomas – yes, Tweedy - yes. Resolution adopted.

WHEREAS, 23 CFR 650 Subpart C, requires initial inspection of all bridges and reinspection at intervals not to exceed two years with the exception of reinforced concrete box culverts that meet specific criteria. These culverts are reinspected at intervals not to exceed four years.

THEREFORE, Edmunds County is desirous of participating in the Bridge Inspection Program. The County requests SDDOT to hire IMEG Consultants Corp (Consulting Engineers) for the inspection work. SDDOT will secure federal approvals, make payments to the Consulting Engineer for inspection services rendered, and bill the County for 20% of the cost. The County will be responsible for the required 20% matching funds.
