April 22, 2025

The Edmunds County Board of Commissioners met at 9:00 a.m. on April 22, 2025 at the county courthouse. Members present were: Dean Mehlhaff, William Tweedy, Micheal J. MINUTES APPROVED: Motioned by Tweedy, seconded by Mehlhaff to approve the minutes of the April 8, 2025 regular meeting and to approve the minutes of the April 8, 2025 Equalization meeting. Motion carried.

MINUTES APPROVED: Motioned by Tweedy, seconded by Geditz to approve the minutes of the April 8, 2025 Weed & Pest Board Meeting. Motion carried.

WEED CONTROL: Michael Jager, Edmunds County Weed Supervisor, discussed the mosquito spraying and weed control plan for 2025 in Edmunds County.

Motioned by Tweedy, seconded by Preszler to adjourn the weed meeting at 10:37 a.m.
Motion carried.

AIRCRAFT: Motioned by Preszler, seconded by Geditz to approve and allow the chairman to sign the Permit Application allowing Dakota Air Spray, to operate, take off, or land aircraft on Edmunds County roads for the year of 2025, for the purpose of servicing said aircraft in preparation for aerial application of chemical or fertilizer materials. The aircraft shall notify the Sheriff's Office, have flag person at each end, operated at their own risk, the county will assume no liability, proof of liability insurance has been filed with the Edmunds County Auditor and the aircraft operator must follow all Federal and State laws and regulations. Motion carried.

BIDS - CULVERTS: Motioned by Mehlhaff, seconded by Preszler to purchase culverts and bridge material off the bid which was awarded to True North Steel, at the January 7, 2025, Beadle County Commission meeting. Motion carried.

BUDGET SUPPLEMENT: Motioned by Preszler, seconded by Geditz to supplement the Highway Budget, in the amount of \$3,026.69, with insurance money received, per SDCL 7-21-32.1. Motion carried.

COURTHOUSE: Motioned by Geditz, seconded by Mehlhaff to hire Exotic Coating LLC to install epoxy flooring on the basement steps and one room in basement in the amount of \$3,662.55. Motion carried.

EMERGENCY MANAGEMENT: Motioned by Tweedy, seconded by Preszler to deny participation in the 2025 Local Emergency Management Performance Grant Program through the SD Office of Emergency Management. Motion carried.

HIGHWAY EQUIPMENT: Motioned by Preszler, seconded by Tweedy to purchase one new 2025 Capital I Grater Mount Mulcher, from Capital I, in the amount of \$43,475.00, for the Highway Department. Motion carried.

NURSE – OFFICE OF PUBLIC HEALTH ALLIANCE: Melanie Kaiser, Community Health Nurse, met with the Board to give a report on services provided by the health department, and discussed the Edmunds County Community Health Contract. Motioned by Mehlhaff seconded by Tweedy to approve and allow the chairman to sign the Edmunds County Community Health Contract between Bowdle Healthcare and Edmunds County, in the amount of \$22,000.00, to provide community health services for the citizens of Edmunds County, effective June 1, 2025 through May 31, 2026. Motion carried.

POOR CLAIM: Motioned by Tweedy, seconded by Mehlhaff to approve county burial assistance expenses for ECO-334. Motion carried.




