**4-H AGREEMENT:** Motioned by Preszler, seconded by Tweedy to approve and allow the chairman to sign the 2026 Memorandum of Understanding, between Edmunds County and SDSU Extension, allowing for a 4-H program in Edmunds County with a full-time county employee to serve in the role of 4-H Youth Program Advisor and Extension Office Administrator. Motion carried.

**2026 BUDGET UPDATE:** Motioned by Tweedy, seconded by Preszler to approve the corrections to the Edmunds County Mill Levy for 2026. The Levy was previously set at 3.330 dollars per \$1,000 of valuation and after finalized growth valuations the levy is now set at 3.206 dollars per \$1,000 of valuation. Motion carried.

**LAW ENFORCEMENT CENTER:** Motioned by Preszler, seconded by Geditz to approve Contingency Draw #3 to the construction costs of the new Law Enforcement Center – HVAC & temp controls and addition of Fire Fighter Control panel in the amount of \$20,000.00. Voice vote; majority - yes, Tweedy – no. Motion carried.


