GIS WEBSITE: Motioned by Geditz, seconded by Tweedy to approve and allow the chairman to sign the 2026 Letter of Agreement between Edmunds County and First District of Local Governments for development, maintenance, and hosting the Edmunds County geographic information system and website. Motion carried.

JAIL: Motioned by Tweedy, seconded by Geditz to approve and allow the chairman to sign the Jail Agreement, with Day County, to provide housing for Edmunds County prisoners at a rate of \$100.00 per day in the Day County Facility. Motion Carried.

Motioned by Preszler, seconded by Tweedy to approve and allow the chairman to sign the Jail Rental Agreements with Campbell, Corson, McPherson, Potter and Spink Counties to provide housing for inmates in the Edmunds County Jail at a rate of \$110.00 per day for each prisoner. Motion carried.

LIQUOR LICENSE: Motioned by Tweedy, seconded by Preszler to set the fee for the open Retail (on-sale) Liquor license at \$600.00. Motion carried.

OPEN MEETING LAWS: The board reviewed and acknowledged the Conducting the Public's Business in Public guide to South Dakota's open meeting laws that was prepared by S.D. Attorney General's Office in partnership with S.D. NewsMedia Association. Motioned by Preszler, seconded by Tweedy to comply with SB-74 and review these laws annually.

PERSONNEL POLICY: Motioned by Preszler, seconded by Tweedy to table the discussion on administrative leave, flex time, sick leave, and vacation policies. Motion carried.

REGISTER OF DEEDS: Motioned by Preszler, seconded by Tweedy to accept the Register of Deeds Statement of Fees for the month of December 2025 in the amount of \$6,538.50. Motion carried.

SD BOARD OF ECONOMIC DEVELOPMENT: Motioned by Preszler, seconded by Geditz to approve and allow the chairman to sign the South Dakota Governor's Office of Economic Development Reinvestment Program Assignment of Payment, between Edmunds County and Century Swine RE, LLC, with a projected amount of \$1,400,000.00 to be paid to Edmunds County. Motion carried.

TRAVEL AUTHORIZATIONS: Motioned by Preszler, seconded by Tweedy to allow all of the Highway employees to attend the Mining Safety and Health Administration Training in Aberdeen on March 10th, William Osborne, Dale Preszler and Jason Shaykett to attend the 2026 SD Weed and Pest Conference in Deadwood on February 18th–20th, and allow Dale Preszler to attend the SD Highway Superintendents Short Course in Deadwood on March 17th–19th. Motion carried.

Motioned by Tweedy, seconded by Preszler to allow Jonathan Waldner to attend the SDSA Winter business meeting and Sheriff's Day at the Capitol in Pierre on January 28th–29th, Cody Peterson to attend Criminal 1 Investigative Interviewing Techniques in Sioux Falls on February 10th–12th, and allow Cody Peterson to attend Pepperball Instructor/Armour Certification training in Olivia, MN on March 24th–25th. Motion carried.


