CANVASS VOTES: The County Auditor and the Board of Commissioners, as the Edmunds County Canvassing Board, canvassed the votes of the June 2, 2026 Primary Election.

The Republican Governor race and the Republican District 3 Commissioner race in Edmunds County Precinct three were selected at random to be hand counted at the June 16, 2026 post-election audit.

HIGHWAY SAFETY GRANT: Motioned by Tweedy, seconded by Preszler to allow Kyle Couchey, Chief Deputy Sheriff, to sign the 2027 Highway Safety Project Grant agreement between Edmunds County and the SD Office of Highway Safety, Federal award in the amount of \$50,000.00. Motion carried.

RESOLUTION – AUTHORIZING EDMUNDS COUNTY TO DESIGNATE A HILLSIDE TOWNSHIP ROAD AS A “COUNTY AID ROAD” FOR DEVELOPMENT AND

AUTHORIZED PUBLIC PURPOSE: The following resolution was introduced by Commissioner Mehlhaff, who moved its adoption: Resolution #2026-6-1, authorizing

Edmunds County to designate a township road as a "county aid road" for development and authorized public purpose. The motion to adopt the resolution was seconded by Micheal J. Geditz. Roll call vote: Mehlhaff - yes, Tweedy - yes, Geditz - yes, Preszler - yes, Thomas - yes. Resolution adopted.

WHEREAS, SDCL 31-13-12 authorizes Edmunds County to designate a township road as a "county aid road" as it deems advisable and in the public interest.

WHEREAS, the Board of Commissioners of Edmunds County feel it is in the best interest of the public to designate the following Hillside Township roadway as a "county aid road":

Five (5) miles of roadway on 143rd Street extending from 342nd Avenue, extending west to 337th Avenue, leading to the site of the Century Swine operation.

THEREFORE BE IT RESOLVED BY THE EDMUNDS COUNTY BOARD OF COMMISSIONERS that the Hillside Township roadway described herein shall be designated as a "county aid road" and thereby allowing for the constructing, graveling, and maintaining such township roadway.
